## Investment policy


The fund invests mainly in Japanese equities.

The fund generally expects that its holdings, and therefore its performance, may differ significantly from those of the benchmark.


The fund may use derivatives for hedging and efficient portfolio management. Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.
