In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment characteristics.


The fund generally expects that its holdings, and therefore its performance, may differ somewhat from those of the benchmark.

The total average modified duration, including cash, ranges from 1 to 5 years. The total duration, including cash, is the benchmark duration plus or minus 2 years.




