### What is the product?

### Туре

The product is a share class of a Investeringsforeningen Danske Invest Select fund. Investeringsforeningen Danske Invest Select is an umbrella structure under UCITS law with several funds.

The prospectus and the periodic reports are made for the whole Investeringsforeningen Danske Invest Select but with information for each fund.

Your investments will not be affected by the development in any other Investeringsforeningen Danske Invest Select fund, as the assets and liabilities of each fund are segregated by law.

#### Term

The fund has not defined maturity date. Liquidation (closure) of a fund may be decided by the general assembly as described in the articles of association.

### Objectives

The objective of this fund is to achieve above-market performance in the long term compared to a broad selection of bonds denominated in euro. The share class is accumulating.

The fund is actively managed, and the allocation between equities and bonds depends on our expectations to the market development. In addition, we take the overall risk in the portfolio into account. All investments can be placed in one asset type.

The fund is categorized under SFDR as article 8 and promotes environmental and/or social characteristics, as well as good governance practices, through screening, restrictions, investment analysis and decision-making as well as active ownership. The fund follows Danske Invest's responsible investment policy.

The fund has no benchmark as the fund's return is aggregated and measured for the investment product in which the fund is included. The fund's performance is measured against an indicative benchmark.

Subscription is only possible for investors with a portfolio management agreement with Danske Bank or other distributor as described in the prospectus.

### Calculation method

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

## What happens if Danske Invest Management A/S is unable to pay out?

The fund assets are kept separate from the management company's own assets. They are safeguarded and controlled by the fund depositary bank and are kept separate from this bank's own assets. Therefore, neither an insolvency of the management company nor of the depositary bank will make you lose the money invested in the fund.
