### What is this product?

#### Type

OTC - Tracker Forward Seller

### Objectives

The objective of this product is to give investors with a currency exposure a right to exchange a currency at a known worst-case fixed exchange rate, while allowing beneficial price fluctuations.

At the expiration time on the expiration date, you will exchange the agreed amount at the highest of either a tracker rate or the market spot rate, including a tracker fee.

In order to benefit from positive price fluctuations, the buyer of a Tracker Forward agrees to exchange the agreed amount at the tracker rate or the market spot rate, including a tracker fee.

Tracker Forwards are binding agreements to exchange an amount in a specific currency (the notional amount) at a price (the tracker rate/market spot rate, including a tracker fee) and on a specific time (the expiration time) to be agreed on between the buyer and the seller.

At time of expiration, the following scenarios apply:

Market spot rate at or below the tracker rate: The investor is obliged to sell the notional amount at the tracker rate.

Market spot rate above the tracker rate: The investor is obliged to sell the notional amount at the higher of the tracker rate and the market sport rate, including a tracker fee.

The terms set out below are illustrative of the terms of a Tracker Forward, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide, that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These events are specified in the product terms and principally relate to the underlying, the product and the condition of you and Danske Bank. The return (if any) you receive on such early termination is likely to be different from the scenarios described above.


### Term

## What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
