What is this product?

Type

OTC - Average Put

Objectives

The objective of this product is to agree that the buyer of an Average Rate Put Option has the right to receive a cash amount in one currency in case the calculated average rate over an agreed fixing schedule is below an agreed option strike rate. In order to get the right to receive a cash amount, the buyer of an Average Rate Put Option agrees to pay a premium to the seller of the Average Rate Put Option.

The size of the payment you are entitled to receive on the settlement date will depend on the difference between the strike rate, the calculated average rate and the agreed amount. You are not entitled to receive any payment before the settlement date.

At the time of expiration, the following scenarios apply:

The calculated average of the market spot rate is below the strike rate: The buyer of an Average Rate Put Option has a right to receive the calculated variable settlement amount from the seller of the Average Rate Option.

The calculated average of the market spot rate is equal to or above the strike rate: No settlement takes place.

The terms set out below are illustrative of the terms of an Average Rate Put Option, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.


Term

An Average Rate Put Option is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products.
