

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products. This document sets out the generic risks of the PRIIP that you may be considering as a financial investment, in order that you can compare to other products. The specific terms of the product that you enter into will set out in the confirmation in relation to that product.

## What is this product?

### Type

OTC - Participating Forward Buyer

### Objectives

The objective of this product is to agree to exchange an agreed amount in one currency for a variable amount in another currency, with the exchanged amount depending on the spot rate in the spot market at the expiration time at a fixed (worst-case) exchange rate. The strike rate is a less favorable exchange rate than the rate in an ordinary foreign exchange agreement with delivery on the same settlement date. In exchange for the less favorable exchange rate, you agree to be protected for the notional amount but only committed for the participation notional amount.

Participating Forwards are binding agreements to buy a variable amount in a specific currency at the time the agreement is entered into (the notional amount/participation notional amount) at a fixed price (the strike rate) and on a specific time (the expiration time) to be agreed upon between the buyer and the seller.

At the time of expiration, the following scenarios apply:

Market spot rate at or above the strike rate: The investor has a right, but not an obligation, to buy the notional amount at the strike rate.

Market spot rate below the strike rate: The investor has an obligation to buy the participation notional amount at the strike rate.

The terms set out below are illustrative of the terms of a Participating Forward, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.

### Intended retail investor

This product is intended for retail investors who

- (I) wish to hold a Participating Forward for the agreed-upon term and do not want to sell it back prematurely and
- (II) are in the position to bear losses that may be unlimited

### Term

The length of a Participating Forward will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into a Participating Forward. A Participating Forward is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

## What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. **Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.
