### What is this product?

OTC - Equity Index Look-Alike Futures - obligation to purchase

#### Objectives

This Equity Index Future gives you the obligation to purchase a specified number of an equity index or a basket of equity indices at a pre-agreed price. The value of the Equity Index Future during the period until expiry depends on the market price of the underlying index, maturity date, interest rates and dividends. The value of the Future at expiry is equal to the difference between the market price of the index on the pre-agreed date and the pre-agreed price. You are not entitled to receive any other payment than that received on pre-agreed dates. The product achieves its objectives by (1) Danske Bank agreeing the terms of the Equity Index Look-Alike Future with you; and (2) Danske Bank giving you the obligation to purchase a specified number of an equity index or basket of equity indices.

The exact terms will be set out in an individual trade confirmation.


The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These events are specified in the product terms and principally relate to the underlying, the product and the condition of you and Danske Bank. The return (if any) you receive on such early termination is likely to be different from the scenarios described above.

#### Intended retail investor

This product is intended for retail investors who understand there is a risk of a loss equal to the difference between the pre-agreed price and zero. We recommend investors to hold the Equity Index Future for a limited period, although investors have the right to hold Equity Index Futures until their expiry date.


#### Term

The expiry date of the Equity Index Future is set out in the confirmation for the product. The product is entered into for its term, although early termination may occur in the event of default by either you or Danske Bank.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. **Be aware of currency risk**.
