What is this product?

Type

OTC - Boosted Forward Buyer

Objectives

The objective of this product is to agree to exchange an agreed amount in one currency for a variable amount in another currency at a predefined fixed exchange rate, with the exchanged amount depending on the spot rate in the spot market at the expiration time. A boosted forward rate is a more favorable exchange rate than the rate in an ordinary foreign exchange forward agreement with delivery on the same settlement date.

In order to get the right to benefit from a more favorable fixed exchange rate, you accept there is a risk of exchanging an amount that is higher than the one you would normally exchange if you were to enter into an ordinary foreign exchange forward agreement with delivery on the same settlement date.

Boosted Forwards are binding agreements to buy a variable amount in a specific currency at the time the agreement is entered into (the notional amount/boosted notional amount) at a fixed price (the boosted forward rate) and on a specific time (the expiration time) to be agreed on between the buyer and the seller.

At the time of expiration, the following scenarios apply:

Market spot rate at or above the boosted forward rate: The investor has a right, but not an obligation, to buy the notional amount at the boosted forward rate.

Market spot rate below the boosted forward rate: The investor has an obligation to buy the boosted notional amount at the boosted forward rate.

The terms set out below are illustrative of the terms of a Boosted Forward, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.


Term

The length of a Boosted Forward will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into a Boosted Forward. A Boosted Forward is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
