

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products. This document sets out the generic risks of the PRIIP that you may be considering as a financial investment, in order that you can compare to other products. ## What is this product?

### Type

OTC - Strangle

### Objectives

The objective of this product is to agree that the buyer of a Strangle has the right, but not the obligation, to exchange an underlying currency exposure at an agreed option strike rate and time.

At the expiration time on the expiration date, you will have a right, but not an obligation, to exchange the agreed amount at an agreed option strike rate.

In order to benefit from having a right, but not an obligation, the buyer of a Strangle agrees to pay a premium to the seller of a Strangle.

Strangles are binding agreements to obtain the right to exchange an amount in a specific currency (the notional amount) at a price (the call strike rate or put strike rate) and on a specific time (the expiration time) to be agreed on between the buyer and the seller.

At the time of expiration, the following scenarios apply:

Market spot rate at or above the call strike rate: The option buyer has a right, but not an obligation, to exchange the notional amount at the call strike rate.

Market spot rate at or below the put strike rate: The option buyer has a right, but not an obligation, to exchange the notional amount at the call strike rate.

Market spot rate between the strike rates: The option buyer has no obligation to exchange the notional amount.

The terms set out below are illustrative of the terms of a Strangle, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.

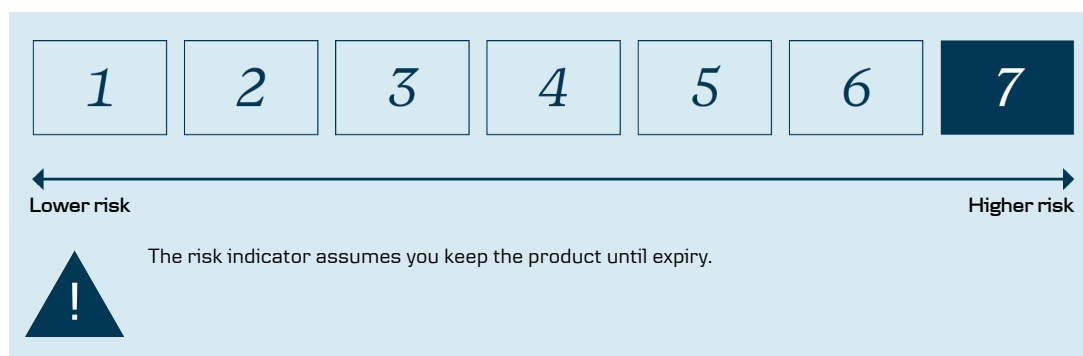

### Term

The length of a Strangle will depend on how long you wish to have the right to exchange the currency. The term will be agreed upon before you enter into a Strangle. A Strangle is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

## What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. **Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.
