### What is this product?

#### Type

OTC - Forward

#### Objectives

The objective of this product is to agree to exchange an agreed amount in one currency for a fixed amount in another currency at a fixed exchange rate at the settlement date.

FX Forwards are binding agreements to exchange an agreed amount in one currency (the notional amount) for a fixed amount in another currency at a fixed exchange rate (the forward rate) on an agreed settlement date.

On the settlement date, the following scenario applies:

The investor has an obligation to exchange the notional amount at the forward rate.

The terms set out below are illustrative of the terms of an FX Forward, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.


### Term

The length of an FX Forward will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into an FX Forward. An FX Forward is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

### What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. Be aware of currency risk.
