### What is this product?

#### Type

OTC - Equity Index Look-Alike Option (Put) - right to sell

#### Objectives

This Equity Option gives you the right, but not the obligation, to sell ('put') a specified number of an equity index or a basket of equity indices at a pre-agreed price. You pay an option premium for this right. The value of the Equity Index Option during the period until expiry depends on the market price of the underlying index, maturity date, volatility, interest rates and dividends. The value of the Option at expiry will be a cash amount equal to the difference between the market price of the index on the pre-agreed date and the pre-agreed price. You are not entitled to receive any other payment than that received on pre-agreed dates.

The product achieves its objectives by [1] Danske Bank agreeing the terms of the Equity Index Option with you; [2] you paying an option premium to Danske Bank; and [3] Danske Bank granting you a right, but not an obligation, to sell a specified number of an equity index or basket of equity indices. You should not exercise this right if doing so would cause you to lose money (because the price is lower than the price at which you could sell the index in the market on the pre-agreed date. Whether or not you exercise the option, Danske Bank will not refund the premium to you.

The exact terms will be set out in an individual trade confirmation.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These events are specified in the product terms and principally relate to the underlying, the product and the condition of you and Danske Bank. The return (if any) you receive on such early termination is likely to be different from the scenarios described above.

#### Intended retail investor

This product is intended for retail investors who understand that the premium paid is not refundable, and that they may receive nothing or less than the amount of the premium paid before expiry of the Equity Index Option. Investors should expect to hold an Equity Index Option until expiry, although special situations may make a shorter holding period favourable.

#### Term

The expiry date of the Equity Index Option is set out in the confirmation for the product. The product is entered into for its term, although early termination may occur in the event of default by either you or Danske Bank.

### What are the risks and what could I get in return?




The summary risk indicator is a guide to the level of risk of this product compared to other products. This graph shows the money you could get back over the next 3 months, under different scenarios, assuming that you invest EUR 10,000.00. This graph illustrates how your investment could perform.
