

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products. This document sets out the generic risks of the PRIIP that you may be considering as a financial investment, in order that you can compare to other products. The specific terms of the product that you enter into will set out in the confirmation in relation to that product.

What is this product?

Type

OTC - Double Knock Out

Objectives

The objective of this product is to agree that the buyer of a Double Knock Out Option has the right, but not the obligation, to exchange an underlying currency exposure at an agreed option strike rate and time, given a predefined barrier event has not occurred.

Trigger rates and a trigger period determine when a barrier event has occurred. The trigger period, during which the trigger rates can be activated, is either the full length of the option period (American), a period within the option period (Window) or at the expiration time (European). In case of a barrier event, the Double Knock Out Option ceases to exist, and the holder of the option no longer has the right to exchange the notional amount.

In order to benefit from having a right, but not an obligation, the buyer of a Double Knock Out Option agrees to pay a premium to the seller of the Double Knock Out Option.

Double Knock Out Options are binding agreements to obtain the right to exchange an amount in a specific currency (the notional amount) at a price (strike rate) and on a specific time (the expiration time) to be agreed on between the buyer and the seller, given a barrier event has not occurred.

At the time of expiration, the following scenarios apply:

Market spot rate has not breached either of the trigger rates in the trigger period: The option buyer has a right, but not an obligation, to exchange the notional amount at the strike rate.

Market spot rate at or beyond the trigger rates in the trigger period: The option buyer has no right or obligation to exchange the notional amount at the strike rate.

The terms set out below are illustrative of the terms of a Double Knock Out Option, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.

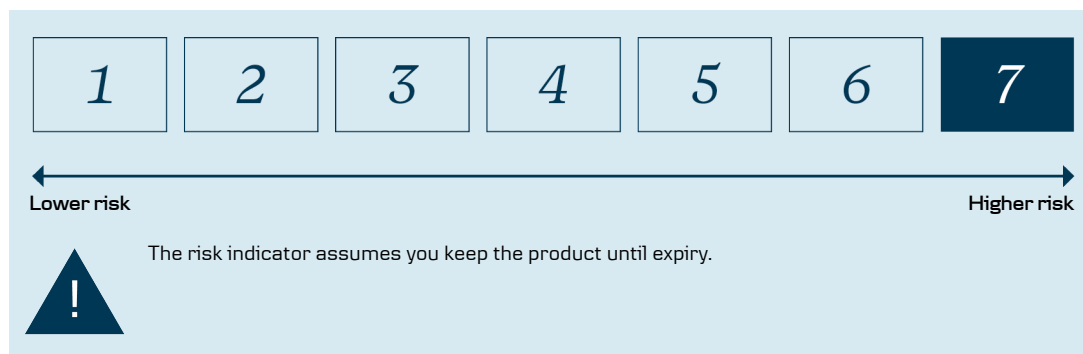
Intended retail investor

This product is intended for retail investors who

- (I) wish to hold a Double Knock Out Option for the agreed-upon term and do not want to sell it back prematurely and
- (II) are not in the position to bear losses that may be unlimited

Term

The length of a Double Knock Out Option will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into a Double Knock Out Option. A Double Knock Out Option is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. **Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.
