### What is this product?

#### Objectives

The objective of this product is to agree to exchange an agreed amount in one currency for a variable amount in another currency at a fixed exchange rate at the settlement date.

NDF contracts are binding agreements to settle the difference between an agreed amount in one currency (the notional amount) exchanged into another currency at a fixed exchange rate (the NDF rate) and at a future market spot rate. The difference is settled in cash at the settlement date.

On the maturity date, the following scenario applies:

The NDF contract will settle against a fixing rate and result in a settlement amount in the settlement currency to be exchanged between the buyer and seller of the NDF contract.

The terms set out below are illustrative of the terms of an NDF contract, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.


### Term

### What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products.
