What is this product?

Type

OTC - Tarf Seller

Term

The length of an FX TARF will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into an FX TARF. An FX TARF is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

Objectives

The objective of this product is to agree to sell an agreed amount in one currency for an agreed amount in another currency, with the exchanged amounts depending on: 1) The comparison between the TARF rate and the fixing rate at the observation date and 2) The accumulated profit of the TARF.

TARFs are binding agreements to exchange a variable amount in a specific currency at the time the agreement is entered into (the notional amount/leveraged notional amount) at a price (TARF rate) and on a specific set of dates (the expiration time/observation frequency) to be agreed on between the buyer and the seller. From the investor's point of view, the TARF rate should usually be higher than the forward price for the agreed currency pair and delivery dates.

On each settlement date, the following scenario applies:

Fixing rate is rate at or below the TARF rate: The investor sells the notional amount at the TARF rate. The calculated difference between the TARF rate and the fixing rate is added to the accumulated profit for all observations.

Fixing is rate above the TARF rate: The investor sells the leveraged notional amount at the TARF rate. Nothing is added to the accumulated profit. The accumulated target is reached: No further settlements will take place and the contract will mature.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur [1] Danske Bank may adjust the product and/or [2] Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.



Risk Indicator
