

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products. This document sets out the generic risks of the PRIIP that you may be considering as a financial investment, in order that you can compare to other products. The specific terms of the product that you enter into will set out in the confirmation in relation to that product.

What is this product?

Type

OTC - Put Non-Deliverable Option

Objectives

The objective of this product is to agree that the buyer of an NDO Put Option has the right to receive a cash amount in one currency in case the market spot rate is below an agreed option strike rate at an agreed time. In order to obtain this right, the buyer of an NDO Put Option agrees to pay a premium to the seller of the NDO Put Option. The size of the payment you are entitled to receive on the settlement date will depend on the difference between the strike rate, the market spot rate and the agreed amount. You are not entitled to receive any payment before the settlement date.

At the time of expiration, the following scenarios apply:

Market spot rate below the strike rate: The option buyer has a right to receive a variable settlement amount based on the notional amount at the strike rate and the market spot rate.

Market spot rate at or above the strike rate: No settlement takes place.

The terms set out below are illustrative of the terms of an NDO Put Option, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.

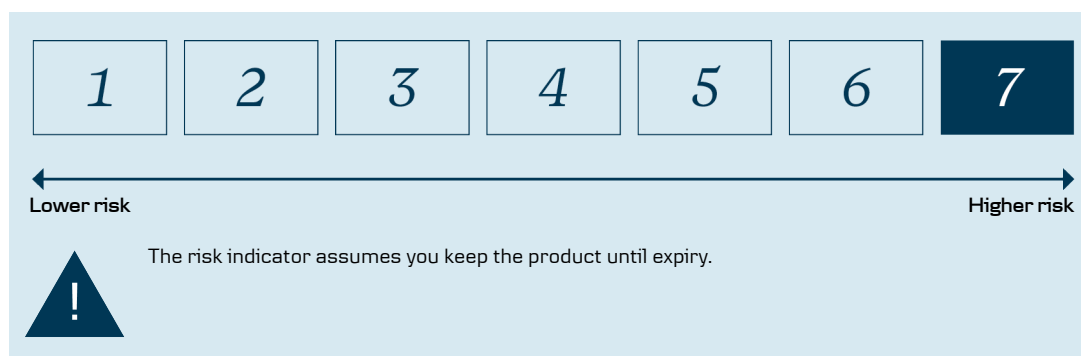

Term

The length of an NDO Put Option will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into an NDO Put Option. An NDO Put Option is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. **Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies.
