Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products. This document sets out the generic risks of the PRIIP that you may be considering as a financial investment, in order that you can compare to other products. The specific terms of the product that you enter into will set out in the confirmation in relation to that product.

What is this product?

Objectives

The objective of this product is to agree to exchange an agreed amount in one currency for a variable amount in another currency at a fixed exchange rate at the settlement date.

NDF contracts are binding agreements to settle the difference between an agreed amount in one currency (the notional amount) exchanged into another currency at a fixed exchange rate (the NDF rate) and at a future market spot rate. The difference is settled in cash at the settlement date.

On the maturity date, the following scenario applies:

The NDF contract will settle against a fixing rate and result in a settlement amount in the settlement currency to be exchanged between the buyer and seller of the NDF contract.

The terms set out below are illustrative of the terms of an NDF contract, but are not the exact terms you agree with Danske Bank. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

The product terms provide that if certain exceptional events occur (1) Danske Bank may adjust the product and/or (2) Danske Bank or you may terminate the product early. These exceptional events in question are specified in the product terms and relate principally to the underlying, the product and conditions pertaining to you or Danske Bank. The return (if any) you receive on such early termination is likely to be different from that received in the scenarios described above.


- (I) wish to hold an NDF contract for the agreed-upon term and do not want to sell it back prematurely and

Term

The length of an NDF contract will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into an NDF contract. An NDF contract is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or Danske Bank.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products.
